Item 2: Approval of Minutes

Marc Litzen moved to approve the September 4, 2014 Parks and Recreation Advisory Board minutes. Gary Schroen seconded. The minutes were approved unanimously.

Item 3: School District / Recreation Program Schedules

Rob Schoeber reported on the significant impact the School District's 2014 calendar change has had on recreation programs and aquatics facilities. The schedule challenges have included major staffing shortages, program restraints, facility obstacles (no SD custodian scheduled during breaks, therefore, no use of the gymnasiums being allowed), scheduling difficulties, etc. At this time, staff is unsure of what to expect during the extended breaks scheduled for the remainder of the school year and is also concerned about additional changes for the 2015-2016 school calendar. Staff is requesting suggestions from the Board as to how to address concerns for future proposed changes. Discussion ensued, with the Board members asking staff to draft a letter to the School District focusing on the "facts" of how the schedule change is impacting the department. Rob Schoeber stated he would draft a letter and bring it to next month's meeting for the Board members to review. It was also suggested the School District board members be invited to a future PRAB meeting to discuss the issue further.

Item 4: Project Updates

Mike Vendegna and Rob Schoeber provided an update on the recent completed North Avenue median project. The scope of the project included repairing the median ends and the damaged curbing, installing the necessary irrigation and backflow preventers, demolishing the existing material, patching asphalt, painting light pole bases, while also installing topsoil, crushed granite, and planting trees (See attached presentation). The next step in the project will be to skip to zone three, which is currently slated to be awarded this winter with construction starting February or March 2015. Rob Schoeber commended the Parks crews for the excellent coordination and teamwork on such a large overnight project. Way to go Parks Crews!

Traci Wieland reported the Matchett Park master plan has been approved by city council and that staff is currently in the process of interviewing consultants for the Las Colonias amphitheater project.

Mike Vendegna reported the damaged grass at Sherwood Park was due to a chemical that the Parks crews do not use in that specific sprayer, and that the test results showed a very large level of nitrogen. Unfortunately, after two investigations, the Consultant has determined the incident was not accidental. Strong safety measures are now being taken to prevent any additional tampering.

Item 5: For the Good of the Community

The Board members briefly discussed the ongoing need for a recreation center.

Kyle Emert suggested the City partner with Gold's Gym to offer racquetball, as well as discussed the possibility of offering a frisbee golf league and unified sports (pairing athletes with special needs athletes).

Congratulations to the Lincoln Park stadium crew, who recently received the "Pioneer Field of the Year" award. Way to go stadium crew!
