AN ORDINANCE.

AN ORDINANCE CONCERNING THE RE-SURVEY OF
FIRST SUB-DIVISION OF THE TOWN OF GRAND
JUNCTION, COLORADO.

Be it Ordained by the Board of Trustees of the Town of Grand Junction:

SECTION 1. That the re-survey of the First Sub-division of the Town of Grand Junction, comprising blocks numbered, seventy-eight (78), seventy-nine (79), eighty (80), eighty-one (81), eighty-two (82), eighty-three (83), ninety-four (94), ninety-five (95), ninety-six (96), ninety-seven (97), ninety-eight (98), ninety-nine (99), one hundred (100), one hundred and one (101), one hundred and two (102), one hundred and three (103), one hundred and four (104), one hundred and five (105), one hundred and sixteen (116), one hundred and seventeen (117), one hundred and eighteen (118), one hundred and nineteen (119), one hundred and twenty (120), one hundred and twenty-one (121), one hundred and twenty-two (122), one hundred and twenty-three (123), one hundred and twenty-four (124), one hundred and twenty-five (125), one hundred and twenty-six (126) and one hundred and twenty-seven (127), as surveyed by A. J. McCune, civil engineer, under contract with the Town of Grand Junction, dated July 15th, 1885, together with the plat thereof, be and the same are hereby adopted as the correct and official survey and plat of said First Sub-division of the Town of Grand Junction, and of the monuments, lots, blocks, streets, avenues and alleys embraced therein.

SEC. 2. The Mayor of Grand Junction is hereby authorized and directed, for and on behalf of the Town of Grand Junction, to execute and acknowledge the plat mentioned in Section one (1) hereof, in the manner provided in An Act of the General Assembly of the State of Colorado, entitled: "An Act for the platting of the whole or any part of the corporate area of cities and incorporated towns heretofore organized, or hereafter to be organized, and to determine the location and boundaries of lots, blocks, streets, alleys, avenues, highways, parks, squares, and all other divisions of land within such corporate area." Approved March 31st, 1885, and to cause the same to be recorded as provided in said act.

SEC. 3. That the corners of Section 14, T. 1 S., R. 1 W. Ute Meridian, as re-established, located and marked by said A. J. McCune under said contract, be and the same are hereby recognized and adopted as the true, correct and official corners of said Section 14.

SEC. 4. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed.
