

ORDINANCE NO. 25. U

An Ordinance Amending Section 1 of Ordinance No. 8 of the City of Grand Junction. Passed and Approved September 26, 1891,

Be it ordained by the City Council of the City of Grand Junction:

Section 1 That section one of an ordinance entitled "An Ordinance Concerning Licenses," passed and approved by the city council of the city of Grand Junction, on September the 26th, 1891, be, and the same is, hereby amended, so as to read as follows:

Sec. 1. No person shall, in this city, contract, conduct, carry on, pursue or engage in any business, avocation or calling in this ordinance named, without first obtaining a license therefor, and shall pay for such license as hereinafter specified as follows, to-wit:

1. Street hawkers, ten dollars per day.
2. Foot peddlers, carrying a pack, one dollar per day.
3. Peddlers with one-horse wagon, two dollars and fifty cents per day.
4. Peddlers with two-horse wagon four dollars per day.
5. For halls, theaters, opera houses or places of amusements, for the exhibition of theatrical performances, musical concerts, shows or exhibitions by traveling performers, and for all other shows, entertainments and performances, license may be issued to any applicant therefor upon the payment of one hundred dollars for the year; and if no such license is issued, then any such show, theatrical play, entertainment, or performance, as aforesaid, shall pay five dollars license per day for each day of such performance.
6. Circus, menagerie, or circus and menagerie, one hundred dollars per day; for each side show or traveling exhibition with circus or menagerie, for which an extra charge is made, ten dollars per day for each exhibition; and provided that no license shall be charged for free lectures.
7. Retail liquor dealer, ten hundred dollars per annum.
8. Wholesale liquor dealers, two hundred dollars per annum.
9. Dealers in wine only, in quantities of four and one-half gallons or more, twenty five dollars per annum.
10. For each express wagon, transfer wagon, job wagon or vehicle used and kept for hire, for carrying articles or property of any description within the limits of this city, twenty-five dollars per annum.

Provided also that the owner or proprietor of every such licensed vehicle shall have affixed to each side of said vehicle the number of the same in plain conspicuous figures, of not less than one and one-half inches in length, which number shall be designated to the owner or proprietor of any such vehicle by the city clerk at the time of issuing license therefor and shall be recorded by the city clerk in the license register upon the issuance of any such license.

All annual license fees shall be payable in semi-annual payments, one-half on the first day of April and one-half on the first day of October of each year.
