Moved by Commissioner Holmburg, seconded by Commissioner Carson, that the Commissioner of Finance and Supplies be authorized and instructed to order, on approval, a siren for the Fire House.

The motion being put, each Commissioner, as his name was called, voted as follows: Cherrington, yea; Vorbeck, yea; Carson, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

Moved by Commissioner Holmburg, seconded by Commissioner Carson, that the Commissioner of Finance and Supplies be authorized and instructed to pay the bill of Hampson Bros. & Valdez for provisions furnished the quarantined poor family out of the charity fund, as drawn on Warrant No. 16,689.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Carson, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

On motion of Commissioner Holmburg, seconded by Commissioner Carson, the Council adjourned.
