

Grand Junction, Colorado
March 16, 1915.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

The following Commissioners, upon call of roll, responded as present: Cherrington, Vorbeck, Rankin, Carson, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of March 9th and adjourned session of March 10th were read and approved.

Mr. H. Piatt appeared before the Council and spoke of a plan to issue 25,000 copies of a Midland Trail log book for distribution in the East, and asked the City to take advertising space in the same.

Moved by Commissioner Vorbeck, seconded by Commissioner Rankin, that the City agree to take a page space in the Colorado-Utah log book, and that it pay \$100 for said space upon sufficient evidence that 25,000 copies of the book have been printed and circulated.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

The following communication was read to the Council:

Grand Junction, Colo.

Dear Sir:

I have sent you by registered mail today interest coupons due Dec. 1, 1914, on \$22,000.00 issue of water bonds.

I have not as yet had any definite understanding as to any arrangements for payment of these bonds, which matured Dec. 1, 1914, I expected that a payment on account of principal would have been made before this. Would you please let me know how you have this matter in mind.

Moved by Commissioner Rankin, seconded by Commissioner Carson, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

The Council then proceeded to open bids for repair of roof and kalsomining interior City Hall. The following bids were opened and read by the Clerk:

For Kalsomining Walls and Cleaning and Varnishing Wood-work:

Ferment Wallpaper and Paint Co., bid \$73.70.

The Mayor Paint Co., bid \$96.60.

Louis Cherveney, bid \$80.00.

For Removing and Replacing Roof according to Specifications:

H. S. Manning and W. S. Aupperle, bid \$85.50.

S. E. Winterburn, bid \$87.50.

Chilius & Diehl, bid \$97.00.

Cannel & Beck, bid \$83.25 and \$4.00 for patching cracks in plaster.

George Klever, bid \$90.00.

Moved by Commissioner Rankin, seconded by Commissioner Carson, that the bid of the Fremont Wallpaper and Paint Co. for the kalsomining and decorating of rooms be accepted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Owing to wording of bids, it was not quite clear to the Council which bid was the lowest for repair of roof, and it was moved by Commissioner Holmburg, seconded by Commissioner Carson, that it be left to Commissioner Rankin to determine which bid for repair of roof and plastering is the lowest, and that he be authorized to let the work to the lowest bidder.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Moved by Commissioner Carson, seconded by Commissioner Rankin, that the Commissioner of Finance and Supplies be authorized and instructed to advertise for bids for the bonds of the proposed paving and sidewalk district, subject to the formation of the district.

The motion carried.

On motion of Commissioner Carson, seconded by Commissioner Holmburg, the Council then adjourned.
