

Grand Junction, Colorado
April 6, 1915.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Rankin, Carson, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of March 30th and adjourned session of April 3d were read and approved.

Mrs. E. D. Wadsworth and Mrs. C. B. Rich of the Cemetery Association appeared before the Council and asked for assistance from the City for maintaining the Orchard Mesa cemeteries.

Moved by Commissioner Rankin, seconded by Commissioner Holmburg, that the Council appropriate \$100.00 out of the General Fund for maintaining the Orchard Mesa cemeteries, and that the Council recommend that the County of Mesa and others interested give a like amount for this purpose.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Rankin, the report was referred to the Mayor.

The quarterly report of the Judge of the Municipal Court was submitted and read. On motion of Commissioner Carson, seconded by Commissioner Rankin, the report was referred to the Auditor.

The quarterly report of the City Treasurer was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Rankin, the same was referred to the Auditor.

The quarterly report of the Chief of the Fire Department was submitted and read. On motion of Commissioner Holmburg, seconded by Commissioner Carson, the report was referred to the Mayor.

The resignation of J. Monroe Stewart, as a member of the Civil Service Commission, was presented and read. On motion of Commissioner Carson, seconded by Commissioner Vorbeck, the resignation was accepted.

The Council then proceeded to open bids for the \$21,000 of bonds of Paving and Sidewalk District No. 5.

The following bids were opened and read:

J. L Oliver, bid \$20,005.00.

Sweet, Causey, Foster & Co., bid \$986.50 for each \$1,000 bond for the first \$15,000 of the \$21,000.

James N. Wright & Co., bid \$21,000 and accrued interest, less \$392.50 for attorney's fees and blank bonds.

The German American Trust Co., bid \$21,025.00, plus accrued interest to date of delivery.

Moved by Commissioner Vorbeck, seconded by Commissioner Carson, that when the Council adjourns it adjourn until 11 o'clock a. m., to-morrow to consider bids for bonds.

The motion carried.

Whereas,

It appears from the report of the Commissioner of Finance & Supplies that an overdraft of \$20.07 is carried on the books of the City Treasurer in an account designated as "Special Water Fund" and

Whereas,

It appears that the need for a Special Water Fund account no longer exists; be it therefore,

Resolved,

That the Commissioner of Finance & Supplies be instructed to transfer said debit balance of \$20.07 to the Water Fund, and that said Special Water Fund account be discontinued and colsed.

Moved by Commissioner Vorbeck, seconded by Commissioner Carson, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted

as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

The following resolution, passed by the Board of Commissioners of Mesa County, was presented and read to the Council:

Resolution.

Whereas, at a meeting of the board of Commissioners for Mesa County held on June 3rd. 1903, a settlement was had with George. J.D. Williams and W.C. McCurdy, Treasurers for the loss of certain County funds through the failure of the Colorado State Bank, by which settlement said Treasurers and their bondsmen were released from liability for said loss, and

Whereas, there is now being carried on the books of the Treasurer as cash an item of \$4696.45 which was lost through said settlement, and

Whereas, the states proportion of said loss has been fully paid and the city of Grand Junction and School Disct. #I have approved such settlement.

Now therefore, Be It Resolved, that the County Treasurer is hereby instructed to charge off said sum of \$4696.45 so lost, and to prorate said loss to the various funds pro-rata to the amount in each of said funds on the date of the failure of said the Colorado State Bank, except that no portion of said loss shall be pro rated to any of the funds for the redemption of bonds or the payment of interest on bonded indebtedness.
