

Grand Junction, Colorado
May 4, 1915.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Rankin, Carson, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of April 27th and special meeting of April 30 were read and approved.

S. R. Voils made application for license as cement contractor.

Moved by Commissioner Rankin, seconded by Commissioner Carson, that the license be granted when the proper bond is filed with the clerk.

The motion carried.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Carson, the same was referred to the Mayor.

The quarterly report of the Commissioner of Health and Civic Beauty was submitted and read. On motion of Commissioner Carson, seconded by Commissioner Holmburg, the report was referred to the Commissioner of Finance and Supplies

The quarterly report of the Commissioner of Water and Sewers was submitted and read. On motion of Commissioner Rankin, seconded by Commissioner Vorbeck, the same was referred to the auditor.

The report of the City Weigher for the month of March having been examined and approved by the Mayor, the same was, on motion of Commissioner Holmburg, seconded by Commissioner Vorbeck, accepted and ordered placed on file.

Moved by Commissioner Rankin, seconded by Commissioner Carson, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted, yea, the Mayor declared the motion carried and the bills allowed.

A proposed ordinance, entitled "An Ordinance Concerning the Cutting of Weeds and Brush, and the Removal of Weeds, Brush and Rubbish," was introduced and read.

Moved by Commissioner Holmburg, seconded by Commissioner Rankin,

that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the proposed ordinance passed for publication.

Moved by Commissioner Holmburg, seconded by Commissioner Rankin, that the City Attorney be instructed to revise the City Ordinances; that he complete the work on or before September 1st, 1915, and that the City shall pay for the stenographic work in connection therewith.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

A communication from Ben Safley in reference to the payment of water bonds now matured was read to the Council: The following proposition as to payment of bonds was made in said letter: \$2,000 to be paid December 1, 1915, and \$3,000 on each June 1 and December 1, of 1916 and 1917, and \$3,000 on June 1, 1918.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the terms of payment of the balance of the \$22,000 water bond issue of date of December 1st; 1899, as proposed in letter of Mr. Ben Safley, dated April 29, 1915, be accepted, and that the Commissioner of Finance and Supplies be instructed to notify Mr. Safley of such acceptance.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea

All the Commissioners having voted yea, the Mayor declared the motion carried.

On motion of Commissioner Rankin, seconded by Commissioner Vorbeck, the Council adjourned.
