The motion carried by a unanimous vote of the Council.

The quarterly reports of the Commissioner of Public Affairs, the Commissioner of Highways and the quarterly report of the City Clerk and Auditor having been examined and approved by the auditor and the Commissioner of Finance and Supplies, the same were, on motion of Commissioner Holmburg, seconded by Commissioner Rankin, accepted and ordered placed on file.
