

Grand Junction, Colorado  
June 8, 1915.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Rankin, Carson, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of June 1st were read and approved.

The following bills having been approved by heads of departments and audited, were read by the Clerk:

Moved by Commissioner Rankin, seconded by Commissioner Carson, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

Moved by Commissioner Carson, seconded by Commissioner Cherrington, that the City trenching machine be rented to Mr. B. W. Vedder at \$10. per day, not including Sundays, provided that machine is not used; time to be counted from date of removal from City storage yard to date of return to same; machine to be returned in as good condition, ordinary wear and tear excepted, as when taken away.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried, and it was so ordered.

On motion of Commissioner Rankin, seconded by Commissioner Carson, M. A. Gifford was granted an expressman's license from April 1 to July 1, 1915, for \$3.75.

Moved by Commissioner Vorbeck, seconded by Commissioner Rankin, that the express license of M. A. Gifford be transferred to E. D. Atkinson.

The motion carried, and it was so ordered.

The following resolution was introduced and read:

Resolution.

Whereas

It appears from the records of the Commissioner of Finance & Supplies that there is due the City of Grand Junction from the Oasis Mutual Water Company of Orchard Mesa the amount of \$115.75 for rent of Trenching machine and Clamps, and \$38.38 for water used as per meter reading of March 15th 1915, and,

Whereas

Repeated promises have been made by said Oasis Mutual Water company regarding payment of the amount due for rent of trenching machine and clamps, which promises have not been lived up to; be it therefore

Resolved

that the commissioner of Water & Sewers be, and he is hereby instructed to shut off the water supply service of the said Oasis Mutual Water Company on the 1st. of July next unless the amount due the city from them is paid in full by that date.

Moved by Commissioner Vorbeck, seconded by Commissioner Rankin, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

The following resolution was introduced and read:

Resolution.

Whereas

On December 16th, 1913 the E 125 ft. of the So. 50 ft. of the No. 100 ft. of lot 22 Capitol Hill Sub. was sold to the City of Grand Junction according to law and tax sale certificate #13933 was issued to the city for such sale, owing to it appearing on the books of the County Treasurer that 1913 assessment under Paving District #4 was unpaid, and

Whereas,

It appears that such unpaid showing was an error on said County Treasurer's books, as said 1913 assessment had been duly paid but erroneously credited; be it therefore

Resolved,

that it is the sense of this council that such tax sale should be cancelled on the records and the owner of said described property be allowed to pay assessments under Paving District #4 in annual installments as provided, the same as if no such sale for unpaid taxes had been made; and be it further

Resolved,

that the Commissioner of Finance & Supplies be instructed to cancel said tax sale certificate #13933, and that a copy of these resolutions be filed with the Clerk and Recorder of Mesa County for entry on his records.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the resolution as read be passed and adopted.

The motion being put, each Commissioner, as his name was called, voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

On motion of Commissioner Carson, seconded by Commissioner Vorbeck, the Council adjourned.
