

Grand Junction, Colorado  
July 6, 1915.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington, in the chair.

The following Commissioners, upon call of roll, responded as present: Cherrington, Vorbeck, Rankin, Holmburg. Absent: Commissioner Carson.

The minutes of the regular meeting of June 29th were read and approved.

The quarterly report of the City Treasurer was submitted and read. On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the report was referred to the auditor.

A committee of the Ministerial Alliance having appeared before the Council and asked for permit to erect a tabernacle on Block 84, owned by the City and County, it was moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that it is the sense of this Council that the Ministerial Alliance be granted permit to erect a tabernacle for holding evagelistic meetings at the corner of Seventh street and White avenue.

The motion carried.

All the Commissioners present having voted yea, the Mayor declared the motion carried, and it was so ordered.

On motion of Commissioner Rankin, seconded by Commissioner Holmburg, the Council then adjourned.
