Grand Junction, Colorado July 20, 1915.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Rankin, Holmburg. Absent: Commissioner Carson.

The minutes of the regular meeting of July 13th were read and approved.

Mr. Charles Quist and others of the Frontier Celebration committee appeared before the Council and asked that the Council to grant all the street concessions for the days of the celebration, August 12, 13 and 14.

The Council agreed to take action in the matter later in the day, and the committee retired.

Mr. Antles, Secretary of the Chamber of Commerce, having appeared before the Council and urged the erection of advertising signs at the Union railway station, it was moved by Commissioner Vorbeck, seconded by Commissioner Rankin, that the City put up two signs, advertising the resources and advantages of the city and valley, at the Union railway depot, the cost to the City of such signs not to exceed twenty dollars.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Holmburg, yea.

All the Commissioners present having voted yea, the Mayor declared the motion carried, and it was so ordered.

The petition of L. J. Campbell and others, calling attention to the condition of the property described as Lots 31 to 36 inclusive, in Block 36, and asking the Council to cause the buildings on said lots to be removed or repaired and the weeds removed, was presented and read.

On motion of Commissioner Rankin, seconded by Commissioner Vorbeck, the petition was referred to the Mayor and City Attorney.

The report of the City Weigher having been examined and approved by the Mayor, the same was, on motion of Commissioner Holmburg, seconded by Commissioner Rankin, accepted and ordered placed on file.

The quarterly report of the City Clerk and Auditor having been

examined and approved by the Commissioner of Finance and Supplies, on motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the report was accepted and ordered placed on file.

All the Commissioners present having voted yea, the Mayor declared the motion carried and the bills allowed.

A proposed ordinance, entitled "An Ordinance Amending Section 36

of of Ordinance Number 178," Passed and adopted June 11, 1910, was introduced and read.

Moved by Commissioner Rankin, seconded by Commissioner Vorbeck, that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Holmburg, yea.

All the Commissioners present having voted yea, the Mayor declared the motion carried and the proposed ordinance passed for publication.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, through the failure of the Colorado State Bank, certain funds in the hands of the County Treasurer of Mesa County were lost, and

WHEREAS, thereafter on June 3d, 1903, a settlement was made between the County Commissioners and the County Treasurer of Mesa County, which provided for the release of claim against such treasurer to the amount of \$4,696.48, and

WHEREAS, \$262.60 of said sum was money of the City of Grand Junction, which sum of money was paid to the City in 1903 and was not withheld or rebated in said year, and

WHEREAS, on March 31, 1915, the County Treasurer of Mesa County in his monthly remittance to the City held back the said sum of \$262.60; now, therefore, be it

RESOLVED, that the City of Grand Junction allow to the County of Mesa and the Treasurer thereof the said sum of \$262.60, being the portion of the City of Grand Junction of said less.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the resolution as read be passed and adopted.

The motion being put, each Commissioner as his name was called, voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Holmburg, yea.

All the Commissioners present having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the City purchase a lung motor, provided the Electric Light Company pay \$50.00 of the cost of the same.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

The matter of the granting of the street concessions to the Frontier Day Celebration committee being taken up for consideration, it was moved by Commissioner Cherrington, seconded by Commissioner Rankin, that the City grant the said concessions as asked for by the committee.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, no; Rankin, yea; Holmburg, no.

The vote being a tie, the motion was declared lost.

On motion of Commissioner Holmburg, seconded by Commissioner Vorbeck, the Council adjourned.
