

Grand Junction, Colorado
August 10, 1915.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

The following Commissioners, upon call of roll, responded as present: Cherrington, Vorbeck, Rankin, Carson, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of August 3d were read and approved.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, there is being organized in the County of Mesa a drainage district for the purpose of draining certain agricultural and other land, and

WHEREAS, the City of Grand Junction would be greatly benefited by such drainage, both indirectly by draining land in the valley adjacent to Grand Junction, and directly by draining land within the city limits that is now threatened with seep, and

WHEREAS, the last Legislature of Colorado passed a law permitting the inclusion of cities and towns within drainage districts by petition of property owners therein; therefore, be it

RESOLVED, that the City Council of the City of Grand Junction does heartily approve of the organization of such drainage district and the inclusion therein of the City of Grand Junction, and recommends that the necessary steps be taken to include Grand Junction within the drainage district now being organized.

Moved by Commissioner Vorbeck, seconded by Commissioner Rankin, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

Mr. Wm. Lynch appeared before the Council and submitted plans and figures for concrete work on Kannak Creek for the protection of pipe line at crossing of creek, offering to do the work for \$530.00.

On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the matter of said work and bid therefor was referred to the Commissioner of Water and Sewers to report at the next meeting of the Council.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

The proof of publication of a proposed ordinance, entitled "An Ordinance Concerning Licenses," was presented and read.

On motion of Commissioner Holmburg, seconded by Commissioner Carson, the proof of publication was accepted and ordered placed on file.

Moved by Commissioner Holmburg, seconded by Commissioner Rankin, that the proposed ordinance be taken up for final passage.

The motion carried and the proposed ordinance was then read by the Clerk.

Moved by Commissioner Holmburg, seconded by Commissioner Rankin, that Section 9 of said ordinance be amended by substituting the word "business" for the words "stable keepers."

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the amendment adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Carson, that the ordinance as read and amended and entitled "An Ordinance Concerning Licenses," be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the ordinance passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the ordinance just passed be numbered 238.

The motion carried and it was so ordered.

The proof of publication of a proposed ordinance, entitled "An Ordinance Amending Section 36 of Ordinance Number 178, passed and adopted June 11, 1910," was presented and read.

On motion of Commissioner Vorbeck, seconded by Commissioner Carson, the proof of publication was accepted and ordered placed on file.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the proposed ordinance be taken up for final passage.

The motion carried and the proposed ordinance was then read by the Clerk.

Moved by Commissioner Rankin, seconded by Commissioner Holmburg, that the ordinance as read and entitled "An Ordinance Amending Section 36 of Ordinance Number 178, passed and adopted June 11, 1910," be passed and adopted.

The motion being put, each Commissioner as his name was called voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the ordinance passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the ordinance just passed be numbered 239.

The motion carried, and it was so ordered.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, Barton & Terrill are constructing a two-story brick building on Seventh street, north of the D. & R. G. R'y Co. right of way, which building is located on the following described real estate, to-wit: Beginning with the intersection of the west line of Seventh street with the north right of way line of the Rio Grande Junction Railroad Co., thence north 47.85 ft., thence west 132 ft., thence south 88.45 ft., thence northeasterly 137.67 ft. to the point of beginning; and

WHEREAS, they desire to connect with the sewer in Sewer District No. 3; therefore, be it

RESOLVED, that the said men be permitted to connect said real estate with said sewer district on the payment to the city of \$36.00; and be it further

RESOLVED, that the said \$36,00 when received be credited to Sewr District No. 3.

Moved by Commissioner Vorbeck, seconded by Commissioner Carson, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea; the Mayor declared the motion carried and the resolution passed and adopted.

In the matter of giving free water to the Fair Grounds, Commissioner Carson, to whom the same had been referred, reported adversely and moved that the request of B. F. Griffith to grant free water to the Fair Grounds be refused, the motion being seconded by Commissioner Holmburg.

The motion carried by a unanimous vote of the Council.

On motion of Commissioner Carson, seconded by Commissioner Holmburg, the Council adjourned.
