

Grand Junction, Colorado
August 17, 1915.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Commissioner Carson, Acting Mayor, in the chair.

Upon call of roll, the following Commissioners responded as present: Carson, Vorbeck, Rankin, Holmburg. Absent: Commissioner Cherrington.

City Attorney Tupper was present.

The minutes of the regular meeting of August 10th were read and approved.

A communication from the Commissioner of Finance and Supplies, submitting a list of water accounts delinquent for water rentals and on which, under the ordinances, water should be shut off, was presented and read. The list showed 2 accounts delinquent 11 quarters; 1 account, 5 quarters; 8 accounts, 3 quarters; 17 accounts, 2 quarters, and 213 accounts delinquent one quarter.

On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the communication was referred to the Commissioner of Water and Sewers.
