

Grand Junction, Colorado, October 5, 1915.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Rankin, Carson, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of September 28th were read and approved.

The petition of Henry R. Rhone and others; the petition of C. P. McCary and others, and the petition of O. D. Williams and others, asking the Council to submit several amendments to the Charter of the city, as stated in said petitions, to the qualified electors at the next general municipal election, were presented and read.

On motion of Commissioner Rankin, seconded by Commissioner Carson, the said several petitions were referred to the City Clerk and City for examination and verification.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the same was referred to the Mayor.

The quarterly report of the City Health Officer was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Rankin, the report was accepted and ordered placed on file.

The quarterly report of the City Clerk and Auditor was submitted and read. On motion of Commissioner Holmburg, seconded by Commissioner Carson, the report was referred to the Commissioner of Finance and Supplies.

The quarterly report of the City Treasurer was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Carson, the report was referred to the auditor.

The quarterly report of the Commissioner of Health and Civic Beauty was submitted and read, and on motion of Commissioner Carson, seconded by Commissioner Rankin, the report was referred to the Commissioner of Finance and Supplies.

The quarterly report of the Chief of the Fire Department was submitted and read. On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the report was accepted and ordered placed on file.

Moved by Commissioner Carson, seconded by Commissioner Holmburg, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

The proof of publication of a proposed ordinance, entitled "An Ordinance Concerning Theatres," was submitted and read.

On motion of Commissioner Vorbeck, seconded by Commissioner Carson, the proof of publication was accepted and ordered placed on file.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the proposed ordinance be taken up for final passage.

The motion carried and the proposed ordinance was then read by the Clerk.

Moved by Commissioner Vorbeck, seconded by Commissioner Rankin, that the proposed ordinance as read and entitled, "An Ordinance Concerning Theatres," be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the ordinance passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Carson, that the ordinance just passed be numbered 240.

The motion carried, and it was so ordered.

John Milne having applied for a vehicle license for the balance of the current fiscal year, it was moved by Commissioner Vorbeck, seconded by Commissioner Carson, that the said John Milne be granted a vehicle license until December 31, upon the payment of \$4.00 to the City Treasurer.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

The following resolution was introduced and read:

RESOLUTION

WHEREAS, the owner of lots 16 and 17 in block 27 in the City of Grand Junction failed and refused for more than thirty days to construct a sidewalk along the north side of said lots although notice to so construct had been legally served on her, and

WHEREAS, under the terms and provisions of Ordinance 178, the City Council has caused the said sidewalk to be constructed by H. A. Polker at a cost of \$41.25.

THEREFORE BE IT RESOLVED that the Mayor and City Clerk are hereby authorized and instructed to issue to said H. A. Polker a certificate for a lien for the said sum of money, which shall be filed in the office of the Clerk and Recorder of Mesa County, Colorado.

Moved by Commissioner Rankin, seconded by Commissioner Holmburg, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, at a regular meeting of the City Council, held on May 4th, 1915, a motion was passed agreeing to pay to Ben Safley for 2 Water Bonds of \$1,000.00 each on December 1, 1915, and

WHEREAS, said Ben Safley now desires that said bonds be paid him on October 10th, 1915, and

WHEREAS, there are sufficient funds in the Water Fund to make such payment to Mr. Safley on October 10th; be it, therefore,

RESOLVED, that the Commissioner of Finance and Supplies be hereby instructed to transfer \$2,000.00 from the Water Fund to the Water

Sinking Fund, and be it further

RESOLVED, that the Commissioner of Finance and Supplies pay Ben Safley for two Water Bonds of \$1,000.00 each on October 10th out of such Water Sinking Fund.

Moved by Commissioner Vorbeck, seconded by Commissioner Carson, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

Moved by Commissioner Rankin, seconded by Commissioner Holmburg, that the Council fix and designate Monday, October 18, as the date for heads of Departments to submit their annual estimates of requirements for their respective departments for the next fiscal year, as provided by the Charter, and that the Commissioner of Finance and Supplies submit his annual general city estimate to the Council on Tuesday, October 26.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Rankin, yea; Carson, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried, and it was so ordered.

On motion of Commissioner Carson, seconded by Commissioner Holmburg, the Council then adjourned.
