Grand Junction, Colorado November 16, 1915.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Carson, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of November 9th and adjourned sessions of November 12th and 13th were read and approved.

A communication from S. W. Ashley in reference to the Kannah Creek telephone line running through his field, was presented and read. Mr. Ashley claimed that no right-of-way had ever been given for said line, and stated that he had offered to take \$27.50 from the Telephone Company for such right-of-way. The communication was ordered placed on file.

A communication from the Commissioner of Finance and Supplies, submitting a list of delinquent water accounts, was presented and read. The communication showed 5 meter accounts delinquent; 48 accounts delinquent from 2 to 12 quarters, and 196 accounts delinquent for one quarter. The list showed a total delinquency amounting to \$2,094.84.

On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the communication was referred to the Commissioner of Water and Sewers.

The motion carried by a unanimous vote of the Council.
