

Grand Junction, Colorado  
December 31, 1915.

The City Council of the City of Grand Junction convened in regular adjourned session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

The following Commissioners, upon call of roll, responded as present: Cherrington, Vorbeck, Holmburg. Absent: Commissioners Carson and Blackstone.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, it appears from the records of the water accounts that the account with house at 260 Ute ave. owned by Mrs. J. B. Barnicle is delinquent to the amount of \$25.90, and water has been turned off for non-payment, and

WHEREAS, said Mrs. Barnicle is a widow with very small means for her support, and is wholly unable to pay up the amount delinquent, and

WHEREAS, it is the sense of this Council that Mrs. Barnicle should have water service if any reasonable arrangement can be made; be it therefore

RESOLVED, that the Commissioner of Water and Sewers be directed to resume serving water at 260 Ute avenue, provided Mrs. Barnicle pays \$1.00 in advance for each month of such service, and that the Commissioner of Finance and Supplies be, and he is hereby authorized to cancel the old delinquent account on his water record.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Holmburg, yea.

All the Commissioners present having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.
