Grand Junction, Colorado January 4, 1916

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Blackstone, Holmburg. Absent: Commissioner Carson.

City Attorney Tupper was present. The minutes of the regular meeting of December 28th and adjourned session of December 31st were read and approved.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the same was referred to the Mayor.

The quarterly report of the City Clerk and Auditor was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the report was referred to the Commissioner of Finance and Supplies.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, the ordinance levying the water assessments made an assessment on each lot in Block "L" in Keith's Subdivision in the City of Grand Junction, and as only lots 1 and 32 in said block are adjacent to a water main and subject to assessment, the assessment against lots 2 to 31 inclusive was an error, and

WHEREAS, lots 19 and 20 were sold by the County Treasurer for failure to pay such assessments and lots 2 to 18 and lots 21 to 31 inclusive have paid said assessment; therefore, be it

RESOLVED, that the Commissioner of Finance and Supplies is hereby authorized and instructed to have released the certificates of sale on said lots 19 and 20 and to refund on demand to the owners of said lots 2 to 18 and lots 21 to 31 both inclusive, on which the assessments have been paid, the amount of the assessments paid thereon.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the resolution as read be passed and adopted.

The motion being put, each Commissioner, as his name was called, voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, no; Holmburg, no.

The vote being a tie, the motion was declared lost.

A proposed ordinance, entitled "An Ordinance Relating to Intoxicating Liquors," was introduced and read.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners vted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the Mayor declared the motion carried and the proposed ordinance passed for publication.

On motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the Council then adjourned until Friday, January 7, at 2 o'clock p. m.
