Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that W. C. McBride be allowed free water on the Coen place, Orchard Mesa, for looking after the city's interests on the Kannah Creek pipe line.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea. All the Commissioners present having voted yea, the Mayor declared the motion carried.

The quarterly report of the City Treasurer was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Blackston, the report was referred to the auditor.

The annual report of the Commissioner of Highways was submitted and read. On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the report was referred to the auditor.

The quarterly report of the Commissioner of Health and Civic Beauty was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the same was referred to the Commissioner of Finance and Supplies.

The following bills having been examined and approved by heads of departments and audited, were read by the Clerk:

The motion carried.
