## Grand Junction, Colorado January 18, 1916

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Blackstone, Holmburg. Absent: Commissioner Carson.

City Attorney Tupper was present.

The minutes of the regular meeting of January 11th were read and approved.

The Denver & Rio Grande Railroad Company having asked for right to take water at some point within the city limits for the Durham stock yards, it was moved by Commissioner Holmburg and seconded by Commissioner Vorbeck, that the City offer to furnish the said Denver & Rio Grande Railroad Co. with water for said stock yards, the meter readings to be added to the readings of the city meters, the Durham consumption to be apportioned double to the city consumption; provided, that the railroad company construct its own pipe line from the city mains to stock yards.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the Mayor declared the motion carried.

The Ross Hardware and Supply Co. having made application for a license to carry on the business of plumbing and having filed its bond, duly examined and approved by the City Attorney, it was moved by Commissioner Blackstone, seconded by Commissioner Holmburg, that a plumber's license be granted to the said Ross Hardware and Supply Co. for the year 1916.

The motion carried and it was so ordered.

The proof of publication of a proposed ordinance, entitled "An Ordinance Relating to Intoxicating Liquors," was presented and read.

On motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the proof of publication was accepted and ordered placed on file.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the proposed ordinance be taken up for final passage.

The motion carried, and the proposed ordinance was then read by the Clerk.

Moved by Commissioner Vorbeck and seconded by Commissioner Blackstone that the proposed ordinance as read and entitled "An Ordinance Relating to Intoxicating Liquors," be passed and adopted. The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the Mayor declared the motion carried and the ordinance passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the ordinance just passed be numbered 245.

The motion carried and it was so ordered.

The proof of publication of a proposed ordinance, entitled "An Ordinance Providing for the Issue by the City of Grand Junction, in the State of Colorado, of its Negotiable Interest Bearing Bonds to be Designated Grand Junction Funding Bonds, Series of January First, 1916, in the Aggregate Amount of Twenty Thousand Dollars (\$20,000,00), for the Purpose of Funding and Redeeming a like Amount of the Outstanding Legal Warrants of the City and the Indebtedness Evidenced Thereby," was presented and read. Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the proof of publication be accepted and placed on file.

The motion carried.

On motion of Commissioner Holmburg, seconded by Commissioner Vorbeck, the Council adjourned until to-morrow, January 19, at 10 o'clock a.m.
