Grand Junction, Colorado January 25, 1916

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Blackstone, Holmburg.

The minutes of the regular meeting of January 18th and adjourned session of January 19th were read and approved.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the City make arrangements with residents near the Indian School on the Jenses line, to furnish water for domestic use, by meter service at regular meter rates.

The motion being put, each Commissioner, as his name was called, voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

The following reports having been examined and approved by the Auditor and the Commissioner of Finance and Supplies, it was moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the same be accepted and ordered placed on file:

Quarterly Reports of the Commissioner of Public Affairs, the Commissioner of Water and Sewers, the Commissioner of Highways, the Commissioner of Health and Civic Beauty, the Judge of the Municipal Court, the City Treasurer, and the City Clerk and Auditor.

Annual Reports of the Commissioner of Public Affairs, the Commissioner of Water and Sewers, the Commissioner of Finance and Supplies, the Commissioner of Highways, the Commissioner of Health and Civic Beauty, the Judge of the Municipal court, and the City Clerk and Auditor.

The motion carried, and it was so ordered.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the Commissioner of Finance and Supplies be authorized and instructed to place the following order for pipe and supplies for the Water Department:

- 5,300 ft. 6 in. Matheson jt. National coated Steel Pipe.
- 2,000 lbs. Pig Lead.
- 3 4-in. 4 ft. Ludlow Hydrants, with secondary gates and boxes.
- 3 6 x 6 x 4 Tees for M. J. Pipe.

3 6 in. Plugs.

2 6 in. Ludlow Gate Valves for M. J. Pipe.

100 ft. 6 Lgs. 4 in. M. J. Nat. Coated Pipe.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the Mayor declared the motion carried.

On motion of Commissioner Holmburg, seconded by Commissioner Vorbeck, the Council adjourned until Monday, January 31, at 10 o'clock a.m.
