## Grand Junction, Colorado February 8, 1916

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vorbeck, Blackstone, Holmburg.

The minutes of the regular meeting of February 1st and adjourned session of February 5th were read and approved.

Communications making applications for appointment to the office of Commissioner of Water and Sewers, made vacant by the death of Commissioner Carson, were received and read from the following:

Petitions were also received and read urging the appointment of the following applicants; W. T. Vedder, H. W. Norgaard, E. R. Romberg, and J. W. Carson.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the applications and petitions were laid on the table.

A communication from the Grand Junction Chamber of Commerce, presenting a resolution passed by that body, was read. The said resolution recommended that, "owing to the necessity for economy in the administration of the city's affairs," the duties of the Water Commissioner be absorbed by the remaining four Commissioners."

The communication was received and ordered filed.

A. Goodman having applied for renewal of license as master plumber, and his bond as such having been examined and approved by the City Attorney, it was moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that a plumber's license be granted to the said Goodman.

The motion carried.

The annual report of the City Health Officer was submitted and read, and on motion of Commissioner Holmburg, seconded by

Commissioner Blackstone, the report was accepted and ordered placed on file.
