

Grand Junction, Colorado
March 21, 1916

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

The following Commissioners, upon call of roll, responded as present: Cherrington, Rankin, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of March 14th were read and approved.

The monthly report of the City Weigher having been examined and approved by the Mayor, the same was, on motion of Commissioner Holmburg, seconded by Commissioner Rankin, accepted and ordered placed on file.

A communication from Benton Canon, County Treasurer, in reference to error made in office of County Treasurer in the sale of certain property for paving tax was read.

The following resolution was thereupon introduced and read:

RESOLUTION.

WHEREAS, through an error in the County Treasurer's office, Lots 1, 2, and 3, in Block 18, Grand Junction, were sold on December 9th, 1915, for the paving tax of District Number 4 and are covered by tax sales numbers 17044, 17045, and 17046, in the sum of \$8.65; and

WHEREAS, Lot numbered 28 in Block 106, Grand Junction, was also sold on December 9th, 1915, for the paving tax of District Number 3, and tax sale number 17043 issued therefor in the sum of \$3.80; therefore, be it

RESOLVED, that the said tax sales be cancelled and the assessments on said real estate be reinstated as though no sale had taken place.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

Moved by Commissioner Vorbeck, seconded by Commissioner Rankin, that that the Council refuse to enter into contract with the Denver & Rio Grande Railroad Company in reference to Fifth street across the tracks of said company.

The motion carried by a unanimous vote of the Council.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the City subscribe for 100 copies of the Midland Trail Log-Book for \$100.00; the City also receive a one-page advertising space in said log-book.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, no; Blackstone, yea; Holmburg, yea.

A majority of the Commissioners having voted yea, the motion was declared carried.

Mayor Cherrington placed in nomination for regular firemen the following named persons who have passed the civil service examination: A. R. Herrmann and F J. Gilley.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that A. R. Herrmann and F. J. Gilley be appointed as regular firemen, under civil service rules.

The motion carried by a unanimous vote of the Council, and A. R. Herrmann and F. J. Gilley were declared duly appointed as regular firemen.

On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the Council then adjourned.
