

Grand Junction, Colorado  
April 11, 1916

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Rankin, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meetings of March 28th and April 4th were read and approved.

The quarterly report of the City Health Officer was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Rankin, the same was accepted and ordered placed on file.

The quarterly report of the Commissioner of Water and Sewers was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Rankin, the report was referred to the Auditor.

The quarterly report of the City Treasurer was submitted and read. On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the report was referred to the Auditor.

The quarterly report of the City Clerk and Auditor was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Rankin, the report was referred to the Commissioner of Finance and Supplies.

The proof of publication of a proposed ordinance, entitled "An Ordinance Providing for the Authorization and Publication of the Revised Ordinances of 1916 of the City of Grand Junction," was presented and read.

On motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the proof of publication was accepted and ordered placed on file.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the proposed ordinance be taken up for final passage.

The motion carried and the proposed ordinance was then read by the clerk.

Moved by Commissioner Rankin, seconded by Commissioner Vorbeck, that the proposed ordinance as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the ordinance passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the Ordinance just passed be numbered 248.

The motion carried, and it was so ordered.

The official bond of A. L. Halligan, policeman, having been examined and approved by the City Attorney, the same was on motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, accepted and ordered placed on file.

Moved by Commissioner Holmburg, seconded by Commissioner Rankin, that the Mayor and Clerk be authorized to sign on behalf of the City the contract leasing to Henry N. Patterson that part of Palmer Park lying west of the D. & R. G. railroad tracks for a term of two years.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

The following bills having been examined and approved by heads of departments and audited, were read by the Clerk:

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

Bids for constructing four inch concrete curbing in Cottonwood Park were received and read as follows: H. A. Polker, bid 19 1-2 cts. per lineal foot; Edw. Johnson, bid 22 cts per lin. foot; Voils Coal Co., bid 22 1-2 cts. per lin. foot.

The bid of H. A. Polker being the lowest, it was moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that said bid be accepted and H. A. Polker awarded the work according to specifications.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that The Daily Sentinel be designated as the city official newspaper from April 15, 1916, to January 1st, 1917.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and The Daily Sentinel made the official newspaper from the date aforesaid.

Moved by Commissioner Vorbeck, seconded by Commissioner Rankin, that the Commissioner of Highways be authorized to purchase for use of the Highway Department one span of mules for \$325.00.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the Council then adjourned.
