## Grand Junction, Colorado May 9, 1916

The official bond of Wm. C. Herrmann as Chief of Police having been examined and approved by the City Attorney, the same was, on motion of Commissioner Blackstone, seconded by Commissioner Holmburg, accepted and ordered placed on file.

All the Commissioners having voted yea, the Mayor declared the motion carried and the proposed ordinance passed for publication.

Bids for the purchase from the City of the Jaynesville pump at the old pump house were opened and read as follows:

Moved by Commissioner Rankin, seconded by Commissioner Blackstone, that the bid of \$150.00 for Jaynesville pump by W. T. Vedder, be accepted.

The motioin being put, each Commissioner as his name was called, voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that all ditch water be shut off for one month from and after this date.

The motion carried, and it was so ordered.

On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the Council then adjourned.
