

Grand Junction, Colorado  
May 16, 1916

The City Council of the City of Grand Junction convened in regular session at four o'clock p.m. in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Rankin, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of May 9<sup>th</sup> were read and approved.

The monthly report of the City Weigher and the quarterly report of the Commissioner of Highways having been examined and approved by the Mayor and Auditor respectively, the said reports were, on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, accepted and ordered placed on file.

A communication from Barton & Terrill in reference to the city hauling and transfer work was presented and read.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that from and after this date and for one year Barton & Terrill be given the city hauling and transfer work, excepting carload shipments.

The motion carried by a unanimous vote of the Council, and it was so ordered.

A communication from the Commissioner of Finance and Supplies in reference to delinquent water accounts was presented and read. The report showed a list of delinquent water users as follows: 1 delinquent meter account; 1 delinquent for 4 1-2 years; 2 for 3 1-2 years; 2 for 5 quarters; 1 for 4 quarters; 2 for 3 quarters; 13 for 2 quarters, and 196 delinquent for one quarter.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the communication, with report, was referred to the Commissioner of Water and Sewers.

B. F. Huggins appeared before the Council and asked for permit to erect a telephone booth at the corner of Fourth and Main Streets.

On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the matter was referred to the Mayor and Commissioner of Highways, with power to act.

B. F. Huggins having applied for an express license, it was moved by Commissioner Vorbeck, seconded by Commissioner Rankin, that such license be granted to Mr. Huggins from date to July 1<sup>st</sup>, 1916, for \$3.00.

The motion carried by a unanimous vote of the Council.

The motion being put, upon call of roll, the Commissioners voted as follows; Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

A proposed ordinance, entitled "An Ordinance Concerning Licenses and Riding Bicycles on Public Sidewalks," was introduced and read.

Moved by Commissioner Holmburg, seconded by Commissioner Rankin, that the proposed ordinance as read be passed for publication.

The motion being put, each Commissioner as his name was called, voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the proposed ordinance passed for publication.

The Commissioner of Finance and Supplies made report in reference to modifying ordinance relating to keeping of high explosives, submitting ordinances of other cities in relation to same.

The Council deferred action in the matter.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that a concrete sidewalk be ordered constructed on the north side of Emerson Park, and that the Commissioner of

Health and Civic Beauty be instructed to receive bids for said work.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the Council then adjourned.
