The motion carried by a unanimous vote of the Council.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the printed Revised Ordinances of 1916 be priced at 50 cents per copy to all who may wish to purchase same.

The motion carried.

On motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the Council adjourned.
