The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the bills allowed.

The bond of S. R. Voils, cement sidewalk contractor, having been examined and approved by the City Attorney, the same was, on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, accepted and placed on file and license ordered issued.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, there is about to be held in Grand Junction a Chautauqua, extending ever seven days, and

WHEREAS, because of the hard times in Mesa county and the fact that this is the first Chautauqua ever held in the city, the attendance is liable to be smaller than desirable, and

WHEREAS, a number of public spirited citizens have guaranteed the expenses of the Chautauqua, and

WHEREAS, such a Chautauqua is desirable as an annual event; therefore, be it

RESOLVED, that the City Council does hereby heartily commend the action of the backers of the Chautauqua in bringing it to Grand Junction, and urges the people of Mesa county to attend the various meetings of the Chautauqua as much as possible, and does further urge the merchants and business people of Grand Junction to permit the largest possible attendance by closing their respective places of business for a time each day during the Chautauqua, so that they and their employees may attend.

Moved by Commissioner Rankin, seconded by Commissioner Holmburg, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

Moved by Commissioner Rankin, seconded by Commissioner Vorbeck, that the Council adjourn.

The motion carried, and the Council then adjourned.
