

Grand Junction, Colorado, August 8, 1916.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

The following Commissioners, upon call of roll, responded as present: Cherrington, Rankin, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of August 1st and adjourned session of August 2d were read and approved.

A communication from A. E. Ballard, town clerk of Fruita, offering city \$100 for old fire boll, was read.

On motion of Commissioner Holmburg, seconded by Commissioner Rankin, the offer of Mr. Ballard was rejected.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that owing to the particular situation of the house at 620 and 624 North First street, the same be specially rated at \$14.00 per year for both premises.

The motion being put upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea. All the Commissioners having voted yea, the motion was declared carried.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the Commissioner of Water and Sewers and the City Attorney be instructed to frame a proposed ordinance in reference to the use of water meters.

The motion carried.
