

Grand Junction, Colorado, August 15, 1916.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Rankin, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of August 8th were read and approved.

A committee from the Chamber of Commerce appeared before the Council and asked that tourists and visitors traveling in automobiles be granted permission to camp in Washington Park.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the matter of permitting auto tourists to camp in Washington Park and of providing signs directing travelers to the place be referred to the Mayor and the Commissioner of Health and Civic Beauty, with power to act.

The motion carried.

Mr. Joseph Quinn appeared before the Council and submitted a bid of \$350.00 for the old pump house and boilers located on the Gunnison river.

Moved by Commissioner Blackstone, seconded by Commissioner Vorbeck, that the bid of Mr. Quinn of \$350.00 for the three boilers and building at the old city pumping plant be accepted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

The monthly report of the City Weigher having been examined and approved by the Mayor, the same was, on motion of Commissioner Holmburg, seconded by Commissioner Vorbeck, accepted and ordered placed on file.

A communication from Commissioner Vorbeck, submitting a list of delinquent water accounts, was presented and read. The list showed 2 meter accounts; one rated water account on which payment has never been made, and which never was on the water books until recently; 3 accounts delinquent three quarters; 19 delinquent two quarters, and 171 delinquent one quarter.

On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the communication and list was referred to the Commissioner of Water and Sewers.

Moved by Commissioner Vorbeck, seconded by Commissioner Rankin, that Wm. Kohler be appointed as a regular fireman.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and Wm. Kohler duly appointed a regular fireman.

On motion of Commissioner Holmburg, seconded by Commissions Blackstone, the Council adjourned.
