

Grand Junction, Colorado, October 3, 1916.

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Rankin, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of September 26th and adjourned session of September 30th were read and approved.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Rankin, the same was referred to the Mayor.

The quarterly report of the City Clerk and Auditor was submitted and read. On motion of Commissioner Holmburg, seconded by Commissioner Rankin, the report was referred to the Commissioner of Finance and Supplies.

A communication from the State Public Utilities Commission, demanding that a report of the city water works be made to said commission, was presented and read.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the Commissioner of Water and Sewers be instructed to send the information requested and that he send a letter with the report stating that the report was given under protest, and that the City of Grand Junction refuses to recognize any jurisdiction of the Commission over the water works system of the City.

The motion carried.

Moved by Commissioner Rankin, seconded by Commissioner Blackstone, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS the building located on lot twenty five (25) in block one hundred eighteen (118) in the City of Grand Junction, also the buildings located on all that part of lot one (1) in block eleven (11) in Richard D. Mobley's First Subdivision to Grand Junction lying South of the extension of the South side alley line of

Block one hundred twenty two (122) in Grand Junction, Colorado, also the building located on lot eight (8) in block one hundred two (102) in the city of Grand Junction, also building located on lots thirteen (13) and fourteen (14) in block one hundred twenty six (126) in the city of Grand Junction, also the house located on lots thirty one and thirty two (31-32) in block thirty six (36) in the city of Grand Junction, are all and each of them by reason of natural decay, defective structure or otherwise unsafe and dangerous to individuals passing along the streets and alleys of said city, or to the life or limb of the persons residing therein, or to the adjacent buildings, or to property in the vicinity,

THEREFORE, be it resolved that each of the said buildings are hereby declared to be a nuisance, and that the marshall of the city of Grand Junction shall at once notify, in writing, the respective owners, occupants or agents of the owners of the same to immediately repair and remedy or abate the said nuisance, and should the respective owners, occupants, or agents of the owners fail to abate such nuisance the said marshall, after consulting with the mayor, shall proceed to demolish or secure the said buildings so as to render them safe.

Moved by Commissioner Cherrington, seconded by Commissioner Holmburg, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

On motion of Commissioner Holmburg, seconded by Commissioner Rankin, the Council then adjourned.
