Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the proposed ordinance be taken up for final passage.

The motion carried and the proposed ordinance was then read by the Clerk.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the proposed ordinance as read and entitled "An Ordinance Levying a Special Assessment on Certain Real Estate in the City of Grand Junction for Benefits Conferred by the Water System of said City," be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried and the ordinance passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the ordinance just passed be numbered 257.

The motion carried and it was so ordered.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the City secure an evergreen for use as a community Christmas tree.

The motion being put, upon call of roll, the Commissioners voted as follows Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the Council adjourned.
