**MINUTES**

**WEDNESDAY, APRIL 1, 2009 2:00 p.m.**

I. **CALL TO ORDER** – The meeting convened at 2:00 p.m. Those present were Hearing Officer Mike Grattan, City Attorney John Shaver, and Deputy City Clerk Debbie Kemp.

II. **APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES**

1. Feather Petroleum Company, dba Stop 'N Save 11, 621 24 Road, Grand Junction, CO 81505, 3.2% Beer Retail (Off Premises)

No one was present representing the applicant.

The application for renewal was found to be in order and approved.

2. Carson, Inc., dba Johny's Beer and Liquor, 666 Patterson Road, Grand Junction, CO 81506, Retail Liquor Store

No one was present representing the applicant.

The application for renewal was found to be in order and approved.

3. Bank 8 Billiards, Inc. dba Bank 8 Billiards, 2460 Patterson, Unit #3, Grand Junction, CO 81505, Tavern

No one was present representing the applicant.

The application for renewal was found to be in order and approved.

III. **APPLICATION FOR SPECIAL EVENTS PERMIT**

1. City of Grand Junction – Parks and Recreation, 1340 Gunnison Avenue, Grand Junction, CO 81501 – Southwest/Arbor Fest on April 25, 2009, 1340 Gunnison Avenue, Grand Junction

Parks and Recreation Director: Rob Schoeber, 2856 Patterson Road, Grand Junction, CO 81504

Rec. Sup./Event Coordinator: Larry Manchester, 2287 Vista Rio Court, Grand Junction, CO 81507

Larry Manchester, Recreation Supervisor, was present.

City Attorney Shaver asked Ms. Kemp if the applicant provided documentation regarding the event. Ms. Kemp stated that the applicant provided completed Special

Event Permit Questionnaire that provides information about the event, a letter giving permission to use Lincoln Park for the event, and a letter regarding stating other facilities are inadequate because they cannot accommodate the numbers of attendees which is expected to exceed 5,000 people. City Attorney Shaver asked Mr. Manchester if he believed the letter that Ms. Kemp read to be a true and accurate representation of what he wrote to the best of his knowledge. Mr. Manchester said he did.

Mr. Manchester gave an overview of the event and said that they have had this event for several years and that it is an outdoor event. Mr. Manchester pointed out that the location is changing just a bit this year at Lincoln Park from where it has been in the past and it should be better because the fencing is already in place.

The application for Special Events Permit was found to be in order and approved.

#### **IV. APPLICATION FOR TRANSFER OF OWNERSHIP OF LIQUOR LICENSES**

1. Yummy, L.L.C. dba Enzo's, 759 Horizon Drive, Grand Junction, CO 81506, Beer and Wine

Member: Vincenzo Favale, 2047 F ¾ Road, Grand Junction, CO 81507

Vincenzo Favale, owner, was present.

City Attorney Shaver asked Ms. Kemp if the location has previously had a license. Ms. Kemp state that it was Diorio's on Horizon.

The application for transfer of ownership was found to be in order and approved.

Mr. Favale stated that he will be expanding soon and will be back to request a modification of premises.

2. La Louisiane, Inc. dba La Louisiane Cajun Seafood, 359 Colorado Avenue #102, 103, and 104, Grand Junction, CO 81501, Hotel and Restaurant – Continued from March 18, 2009

President/Owner: Sue Perkins, 2718 Caribbean, Grand Junction, CO 81506

Sue Perkins, President/Owner, was present.

Ms. Kemp stated that the reason that this was reset from the previous meeting is because no one was present representing the applicant on March 18<sup>th</sup>. Ms. Kemp stated that all requested reports were in order and that the Health Department should be conducting their routine inspection any day. Ms. Perkins said that the Health Department conducted the inspection on March 31<sup>st</sup> and a couple of problems were fixed at the time of inspection. Ms. Perkins also apologized for not being present at the March 18<sup>th</sup> meeting.

Hearing Officer Grattan asked if Ms. Perkins is currently selling liquor. Ms. Kemp stated that Ms. Perkins was issued a temporary permit to sell liquor.

City Attorney Shaver asked about the #102, #103, and #104 of the address. Ms. Perkins explained that #102 is the bar, #103 is the dining area, and #104 is the kitchen.

City Attorney Shaver asked if they are all part of the licensed premises. Ms. Kemp stated that they are.

The application for transfer of ownership was found to be in order and approved.
