MINUTES

WEDNESDAY, JULY 1, 2009 2:00 p.m.

- I. **CALL TO ORDER** – The meeting convened at 2:00 p.m. Those present were Hearing Officer Mike Grattan, City Attorney John Shaver, and Deputy City Clerk Debbie Kemp.

Hearing Officer Grattan advised that since the only applicants in the room were for the new liquor license for a retail liquor store that he would hear this item first.

- II. **APPLICATION FOR NEW LICENSE – RESOLUTION AND FINDS AND DECISION**

1. Grapes, Grain & Barley Discount Liquor Inc., dba Grapes, Grain & Barley Discount Liquor, 1040 Independent Avenue, Grant Junction, CO 81505, Retail Liquor Store

President: Katherine E. Guth, 3635 Bell Ct., Grand Jct CO 81506

VP: Bradley A. Guth, 125 Franklin Ave., Grand Jct CO 81505

Sec./Tres.: Gregory A. Guth, 3635 Bell Ct., Grand Jct CO 81506

Gregory Guth, Katherine Guth, and Bradley Guth, shareholders for the corporation, were present.

Ms. Kemp reported the paperwork was found to be in order and accepted. The applicant requested a concurrent review. All reports came back fine from the Police Department, Code Enforcement, and the Sales Tax Department.

Ms. Kemp read the results of the survey into the record (see attached).

City Attorney Shaver asked Mr. Gregory Guth who conducted the survey. Mr. Guth said that it was his wife, Katherine, son, Bradley, and himself. City Attorney Shaver asked Mr. Guth if he concurred with the results Ms. Kemp read into the record. Mr. Guth agreed. City Attorney Shaver asked Mr. Guth how and when the survey was conducted. Mr. Guth said that between June 2nd and June 22nd, they went door to door, advised people that they were wanting to open a family run liquor store and asked if they would answer the questions. City Attorney Shaver asked Mr. Guth if the people who said “no” signed the survey. Mr. Guth said some did and some didn't. City Attorney Shaver asked Mr. Guth about the exhibits that were submitted along with the survey results, if the numbers reflected any additional times they tried to contact each address. Mr. Guth said that they did not go back a second time.

Hearing Officer Grattan asked Mr. Guth if he wanted to add anything. Mr. Guth said he was raised in Grand Junction. He was president of a beer and liquor distributorship, and therefore, knows liquor laws. He decided that he wanted to open a new family business and that is why they chose a liquor store. Mr. Guth said that they have another son who is less than a 10% shareholder.

Hearing Officer Grattan found the requirements have been met and approved the new retail liquor store license on the local level. The City Clerk's office will prepare a resolution for Hearing Officer Grattan's signature.

III. APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES

1. The Denville Corporation dba Cottonwood Liquors, 2513 Hwy 6&50, Grand Junction Co 81505, Retail Liquor Store

No one was present representing the applicant.

The application for renewal was found to be in order and approved.

2. Feather Petroleum Company dba Stop N Save No. 4, 2700 Highway 50, Grand Junction CO 81505, 3.2% Beer Retail (Off-Premises)

No one was present representing the applicant.

Ms. Kemp reported that even though the applicant is requesting renewal of their 3.2% beer license, they are currently not selling beer at this location which was confirmed by PST Lisa Maestas, Liquor Enforcement/Investigations.

The application for renewal was found to be in order and approved.

3. Rockslide Brew Pub Inc., dba Rockslide Brew Pub, 401 Main Street, Grand Junction CO 81501, Brew Pub

No one was present representing the applicant.

Ms. Kemp reported that the applicant had an alcohol violation for allowing a patron to walk out of the establishment with a beer bottle. PST Lisa Maestas, Liquor Enforcement/Investigations, mailed a Notice of Liquor Law Violation to the establishment, but no criminal or administrative action was taken against the license.

The application for renewal was found to be in order and approved.

4. CEC Entertainment Inc., dba Chuck E Cheese's, 2424 Hwy 6&50, Grand Junction CO 81505, Hotel and Restaurant

No one was present representing the applicant.

The application for renewal was found to be in order and approved.

5. El Tapatio LLC, dba El Tapatio, 1145 North Avenue, Grand Junction CO 81501, Hotel and Restaurant

No one was present representing the applicant.

The application for renewal was found to be in order and approved.

6. Rafael Cisneros dba Las Palmas Mexican Restaurant, 752 ½ Horizon Drive, Grand Junction, CO, 81506, Hotel and Restaurant – Continued from June 17, 2009

No one was present representing the applicant.

Ms. Kemp reported that this had been continued from June 17, 2009 due to the seriousness of the warning given by Ms. Maestas for the applicant having 3.2% beer in his establishment and several violations with the Health Department. Ms. Kemp stated that the violations have been cleared up with the Health Department; however, Ms. Peterson had mailed a certified, return receipt requested letter to Mr. Cisneros requesting his presence at this meeting. The letter was signed for by Mr. Cisneros.

Hearing Officer Grattan continued this application for renewal until the July 15, 2009 meeting and asked that either Ms. Kemp or Ms. Peterson notify Mr. Cisneros again by certified mail that he needs to be present.

Grapes, Grain & Barley Discount Liquor Inc. filed an application with the Local Licensing Authority on May 29, 2009 for a new retail liquor store liquor license permitting sales of malt, vinous and spirituous liquors in sealed containers not for consumption at place where sold at 1040 Independent Avenue under the trade name of Grapes, Grain & Barley Discount Liquor. The application and supplementary documents were reviewed, found to be in order and accepted. A copy was sent to the State Liquor Enforcement Division for a Concurrent Review. The hearing date was set for July 1, 2009. The Notice of Hearing was given by posting a sign on the property on or before June 21, 2009 and by publishing a display ad in the Daily Sentinel on June 19, 2009.

In order to address the reasonable requirements of the neighborhood and the desires of the adult inhabitants of the neighborhood, the applicant conducted a survey. The neighborhood was defined as the area bounded on the North by Patterson, on the South by the Colorado River, on the East by 1st Street, and on the West by 24 ½ Road and extending west along Highway 340 to the Redlands Canal and Riverside Area is included to the South. The area was extended due to the low residential in a half mile area.

1. As an owner of property in the neighborhood, an employee or a business lessee of property in the neighborhood, and/or an inhabitant residing in the neighborhood for more than six months each year, I believe the reasonable requirements of the neighborhood are already being met by other existing outlets.

Exhibits were provided for a record of the attempts of 361 due to no answer, no solicitation, non participant, religious reasons, big dogs in yard, no soliciting, just moved in, vacant or for sale or rent property, or under 21 years of age. These are attached as Exhibits Pages 1-10.

The Grand Junction Police Department has investigated the individuals for local criminal history. The fingerprints have been forwarded to CBI/FBI for further processing. Reports have been requested by the Grand Junction Fire Department, Code Enforcement, and City of Grand Junction Sales Tax Department.

There are 4 similar-type outlets in the survey area. They are Cottonwood Liquors, Crossroads Wine and Spirits (which are moving their location), Grand Central Liquors, and Andy's Liquor Mart.
