**MINUTES**

**WEDNESDAY, DECEMBER 16, 2009 2:00 p.m.**

I. **CALL TO ORDER** – The meeting convened at 2:00 p.m. Those present were Hearing Officer Mike Grattan, City Attorney John Shaver, and Deputy City Clerk Debbie Kemp.

II. **APPLICATIONS TO RENEW LIQUOR AND BEER LICENSES**

1. KMG Enterprises, Inc., dba Boston's The Gourmet Pizza, 2404 F Road, Grand Junction, CO 81505, Hotel and Restaurant

No one was present representing the applicant.

The application for renewal was found to be in order and approved.

2. Brinker Restaurant Corporation dba Chili's Grill & Bar, 584 24 ½ Road, Grand Junction, CO 81505, Hotel and Restaurant

No one was present representing the applicant.

The application for renewal was found to be in order and approved.

3. Robert J. Wilcox Inns, Inc. dba West Gate Inn, 2210 Hwy. 6 & 50, Grand Junction, CO 81505, Hotel and Restaurant

No one was present representing the applicant.

The application for renewal was found to be in order and approved.

4. Bub's Field on the Horizon, LLC dba Bub's Field Sports Pub, 715 Horizon Drive, Suite 1, Grand Junction, CO 81506, Tavern

David Elliott, co-owner of Bub's Field Sports Pub, was present.

The application for renewal was found to be in order and approved.

5. Stoner Enterprises, LTD dba Andy's Liquor Mart, 922 N. 1<sup>st</sup> Street, Grand Junction, CO 81501, Retail Liquor Store

Cindy Axelsen, Manager of Andy's Liquor Mart, was present.

Ms. Kemp reported that the applicant had disclosed a violation from March 2009. An employee had sold to a minor with fake identification. They were fined with a two week closure.

City Attorney Shaver asked Ms. Kemp if that was the only violation in the last year that she is aware of. Ms. Kemp said it is the only violation that she was aware of.

City Attorney Shaver asked Ms. Axelsen if that was the only violation in the last year. Ms. Axelsen said yes, they did have another violation, but that was the year before.

Ms. Axelsen said that they are doing as much as they can, working with the Police Department, and trying to make it as safe as possible.

The application for renewal was found to be in order and approved.

### III. **APPLICATION TO RENEW LIQUOR AND BEER LICENSE AND CHANGE IN TRADE NAME**

1. L & B, Inc. dba Fast Eddy's, 1224 N. 25th Street, Grand Junction, CO 81501, Tavern

Trade name change from Fast Eddy's to Fast Eddy's Sports Bar & Grill

William and Adele Lloyd, owners of Fast Eddy's, were present.

Ms. Kemp stated that the Police Department had reported a possible violation of over service to a patron on December 1, 2008, but that the case was not investigated because there was no video of the incident provided. The Police Department also reported that William Lloyd was arrested on November 3, 2009 for unlawfully entering the vehicle of another and removing items without permission, but that Mr. Lloyd has not been to court on this matter.

The application for change in trade name was found to be in order and approved.

City Attorney Shaver asked about the incident of possible over service. Ms. Lloyd advised that they are having a problem with their video surveillance system and cannot archive old information. She advised that they would have provided a video if they had it.

City Attorney Shaver asked Mr. Lloyd if the incident involving him on November 3, 2009 happened at 1224 N. 25<sup>th</sup> Street. Mr. Lloyd said no, it did not.

Hearing Officer Grattan asked PST Lisa Maestas if what Ms. Lloyd reported about the first incident is consistent with her understanding. Ms. Maestas said yes, it is somewhat; when she went in to get the video tape, it wasn't available and she was advised they would call when it is available and they never called.

The application for renewal was found to be in order and approved.
