## Grand Junction, Colorado January 2, 1917

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

The following Commissioners, upon call of roll, responded as present: Cherrington, Rankin, Vorbeck, Blackstone, Holmburg.

The minutes of the regular meeting of December 26th and adjourned session of December 30th were read and approved.

The following resolution was introduced and read:

## RESOLUTION.

WHEREAS, it is proposed to open up a public country road on Purdy Mesa that will shorten the distance from this city to the Intake on Kannah Creek about four miles, the said road being built by Mesa County and certain interested ranchers, and

WHEREAS, the City has been requested to contribute \$350.00 towards building the fences adjoining the said new road; therefore, be it

RESOLVED, that the City of Grand Junction will pay the sum of \$350.00 towards fencing said road, the said money to be paid when the said road as proposed has been built and put in fair condition up to the Kannah Creek Intake, and also when the county has secured the right-of-way for said road and has accepted the said road as a county road; the said money to come one-half from the General fund and one-half from the Water fund.

Moved by Commissioner Rankin, seconded by Commissioner Blackstone, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the resolution passed and adopted.

The report of the City Weigher for the month of December was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the same was referred to the Mayor.

A. Goodman made application for renewal of license as master plumber, and it was thereupon moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the license be granted upon the filing and acceptance of the proper bond. The motion carried.
