March 6, 1917

All the Commissioners present having voted yea, the motion was declared carried and the bills allowed.

In reference to the matter of the water rental on the old O'Boyle place on Hale avenue, Commissioner Rankin recommended that the place be rated as a five room house while only partially occupied.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone the report and recommendation of Commissioner Rankin was accepted.

On motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the Council adjourned.
