

Grand Junction, Colorado
April 3, 1917

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

The following Commissioners, upon call of roll, responded as present: Cherrington, Rankin, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of March 27 were read and approved.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Rankin, the same was referred to the Mayor.

The quarterly report of the City Clerk and Auditor was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the same was referred to the Commissioner of Finance and Supplies.

Moved by Commissioner Rankin, seconded by Commissioner Blackstone, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the bills allowed.

The quarterly report of the Chief of the Fire Department was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the same was accepted and ordered placed on file.

The official bond of A. L. Halligan, policeman, and the bonds of John Fuite and J. E. McKenzie, master plumbers, having been examined and approved by the City Attorney, the same were on motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, accepted and ordered placed on file.

Bids for the construction of 400 feet, more or less, of concrete curbing on the north side of Emerson Park were opened and read as follows:

C. J. Mapes, bid 35 cents per linear foot.
Veils Coal Co., bid 30 cents lin. feet.
Frank E. Welch, bid 28 cents per lin. feet.

Moved by Commissioner Holmburg, seconded by Commissioner Rankin, that the bid of Frank E. Welch be accepted, conditioned on the filing and approval of the proper bond.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Mayor Cherrington recommended that an are light be placed at the intersection of Spruce street and Rood avenue.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the recommendation be concurred with and an are light ordered placed at the intersection of Spruce street and Road avenue.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried.

On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the Council adjourned until to-morrow, April 4, at four o'clock p. m.
