

Grand Junction, Colorado
April 17, 1917

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Rankin, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of April 10th were read and approved.

The following reports were submitted and read:

Quarterly report of the Commissioner of Public Affairs.
Quarterly report of the Commissioner of Highways.
Quarterly report of the Judge of the Municipal Court.
Quarterly report of the Commissioner of Water and Sewers.
Quarterly report of the City Treasurer.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the above reports were referred to the Auditor.

The Quarterly Report of the Commissioner of Health and Civic Beauty was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Rankin, the same was referred to the Commissioner of Finance and Supplies.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the Commissioner of Finance and Supplies be authorized and instructed to order for the Fire Department one full set of Goodyear Standard truck tires.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

George Fletcher having applied for renewal of master plumbers' license, it was moved by Commissioner Rankin, seconded by Commissioner Vorbeck, that the license be granted. The motion carried.

The bond of George Fletcher as master plumber having been examined and approved by the City Attorney, the same was on motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, accepted and ordred placed on file.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

The Mayor recommended the re-appointment of Forest J. Gilley as a regular Fireman.

Moved by Commissioner Vorbeck, seconded by Commissioner Rankin, that the Mayor's recommendation be concurred in, and that Forest J. Gilley be appointed a regular Fireman, his appointment to date from April 1st.

The motion carried by a unanimous vote of the Council, and Forest J. Gilley was declared duly appointed as a regular Fireman.

Moved by Commissioner Holmburg, seconded by Commissioner Rankin, that the Commissioner of Finance and Supplies be authorized and instructed to advertise for bids for the 6 per cent. bonds of the proposed Sidewalk District No. 2 in the amount of \$20,000, more or less, subject to the completion of the district.

The motion carried by a unanimous vote of the Council.

On motion of Commissioner Holmburg, seconded by Commissioner Vorbeck, the Council adjourned.
