

Grand Junction, Colorado
August 7, 1917

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Rankin, Blackstone, Holmburg. Absent: Com. Vorbeck.

The minutes of the regular meeting of July 31st were read and approved.

The report of the City Weigher for the month of July was submitted and read, and on motion of Commissioner Rankin, seconded by Commissioner Holmburg, the same was referred to the Mayor.

All the Commissioners present having voted yea, the Mayor declared the motion carried and the bills allowed.

Moved by Commissioner Rankin, seconded by Commissioner Blackstone, that the City Treasurer be authorized and instructed to accept \$50.00 in settlement of disputed claim for water used by J. W. Watson up to July 3d, 1917.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

E. P. Bliss appeared before the Council and made complaint about the cutting down of cottonwood trees on his property at the corner of Twelfth street and Colorado avenue.

On motion of Commissioner Rankin, seconded by Commissioner Blackstone, the matter of the complaint was referred to Commissioners Blackstone and Holmburg for investigation.

Moved by Commissioner Rankin, seconded by Commissioner Blackstone, that the flat rate for water for the Currie Canning Factory be fixed at \$70.00 per month for the canning season.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

On motion of Commissioner Rankin, seconded by Commissioner

Blackstone, the Council adjourned.
