Grand Junction, Colorado September 4, 1917

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

The following Commissioners, upon call of roll, responded as present: Cherrington, Rankin, Vorbeck, Blackstone, Holmburg.

The minutes of the regular meeting of August 28th and adjourned session of August 29th were read and approved.

A communication from the U.S. Reclamation Service in reference to the installation of a water gauging station at Kannah Creek was presented and read.

Moved by Commissioner Rankin, seconded by Commissioner Holmburg, that the City enter into an agreement with the U.S. Reclamation Service for the installation of a water measuring device at Kannah Creek, the City to pay one-half of the cost thereof, or \$50.00, as per letter of said service.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea. All the Commissioners having voted yea, the motion was declared carried.

Two communications were received and read from the State Public Utilities Commission--one in reference to the blocking of street crossings (case No. 472), and the other concerning the examination of the city's water system.

The quarterly report of the Commissioner of Highways was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Rankin, the same was referred to the auditor.

The monthly report of the city weigher was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Rankin, the same was referred to the Mayor.

Goldberg & Leff having made application for a license as junk dealers and their bond having been approved by the city attorney, it was moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the bond be accepted and the license granted. The motion carried.
