Grand Junction, Colorado October 16, 1917

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Commissioner Rankin, acting Mayor, in the chair.

Upon call of roll, the following Commissioners responded as present: Rankin, Vorbeck, Blackstone, Holmburg. Absent: Commissioner Cherrington.

The minutes of the regular meeting of October 9th and adjourned session of October 11th were read and approved.

The quarterly report of the Commissioner of Water and Sewers and the quarterly report of the City Treasurer were submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the same were referred to the Auditor.

The quarterly report of the City Clerk and the quarterly report of the Commissioner of Health and Civic Beauty were submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the same were referred to the Commissioner of Finance and Supplies.

The quarterly report of the Public Librarian was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Vorbeck, the same was accepted and ordered placed on file.

The quarterly report of the City Health Officer was submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the same was accepted and ordered placed on file.

All the Commissioners present having voted yea, the motion was declared carried and the bills allowed.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the Commissioner of Finance and Supplies be authorized to sell the city's concrete mixer for \$500.00.

The motion being put, upon call of roll, the Commissioners voted as follows: Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

A proposed People's Ordinance, entitled "An Ordinance Contracting for Electric Current for Municipal Purposes, to be Furnished by The Grand Junction Electric, Gas and Manufacturing Company, its Successors and Assigns, to the City of Grand Junction, Colorado," was introduced and read.

The following resolution was thereupon introduced and read:

RESOLUTION

WHEREAS, the streets of the City of Grand Junction are now being lighted by The Grand Junction Electric, Gas and Manufacturing Company, under a Contract between the said Company and the said City, which contract will terminate February 11th, 1918, and

WHEREAS, the said lights now in use are of a form and character that have grown out of date and it is desired by both the said City and the said Company that a new contract be entered into, which shall provide for newer and more up to date lighting and for a revision of the prices therefor, and

WHEREAS, the City Council of said City and the said Company has caused to be prepared an Ordinance contracting for electric service for municipal purposes to be furnished to the said City by the said Company, which Ordinance the said Company has heretofore agreed to accept if the said Ordinance is adopted by the qualified electors of the City of Grand Junction at the regular election to be held November 6th, 1917, and

WHEREAS, under the Charter of the said City, the question of entering into a Contract for service for a ten (10) year period must be submitted to the qualified electors of the said City for their adoption and ratification.

THEREFORE, be it resolved by the City Council of the City of Grand Junction, Colorado, that at the regular municipal election to be held in said City on November 6th, 1917, which election is hereby called for said date, the question of adopting the said Ordinance described in this resolution be and the same hereby is submitted to the qualified electors of the said City of Grand Junction, Colorado, for their adoption or rejection. The votes shall be by ballot of the form hereinafter provided and said election shall be in all respects as near as may be in the manner prescribed by the laws of the State of Colorado and the Charter of the City of Grand Junction, Colorado in cases of election for municipal officers.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the resolution as introduced and read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried and the resolution passed and adopted.

A proposed People's Ordinance, entitled "An Ordinance in Reference to the Salaries of the Commissioners of the City of Grand Junction," was introduced and read.

The following resolution was thereupon introduced and read:

WHEREAS, the Commissioner of Public Affairs and the Commissioner of Water and Sewers, under the Charter, receive a monthly salary of \$125.00 and the remaining three Commissioners receive a salary of \$100.00 per month, and

WHEREAS, in the opinion of the City Council, each member of the City Council should receive an equal monthly salary of \$125.00, and

WHEREAS, Section 35 of the Charter provides that the question of changing or fixing the salaries of the Commissioners of the said city may be submitted to the qualified electors of said city at any regular election; therefore, be it

RESOLVED, that an ordinance entitled "An Ordinance Concerning the Salaries of the Commissioners of the City of Grand Junction" be and the same is hereby submitted to the qualified electors of the said city at the regular election to be held November 6, 1917, for their adoption or rejection.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the resolution as introduced and read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried and the resolution passed and adopted.

The following resolution was introduced and read:

RESOLUTION

WHEREAS, the City of Grand Junction, Colorado, does not now possess a public park sufficient in size to permit of the playing of base ball or other games, or the holding of fairs and other large meetings, and

WHEREAS, there lies adjacent to the said City a field of forty acres which has been improved by the building of a grandstand and other buildings for the holding of fairs, and by the growth of a large number of shade trees, the said tract of land being described as follows, to-wit: The Northwest quarter of the Northwest quarter (NW1/4 NW1/4), Section Thirteen (13), Township One (1) South of Range One (1) West of the Ute Meridian in Mesa County, Colorado, subject to rights of way for roads and ditches already established, and

WHEREAS, the owner of said described real estate desires to sell the same for the price of Twenty Thousand Five Hundred (\$20,500.00) Dollars and has given, for a valuable consideration, to the said City of Grand Junction, Colorado, an option to purchase the said real estate and the improvements thereon, free and clear of all encumbrances, for Twenty Thousand Five Hundred (\$20,500.00) Dollars, the said option to expire April 1st, 1918, and

WHEREAS, the City Council of said city has caused to be prepared an Ordinance authorizing and instructing the City Council of the City of Grand Junction, Colorado, to purchase the said real estate and authorizing the issuance and sale of Bonds for the purpose of securing money with which to pay for said real estate.

THEREFORE, BE IT RESOLVED by the City Council of the City of Grand Junction, Colorado, that at the regular municipal election to be held in said City on November 6th, 1917, which election is hereby called for said date, at said election the question of adopting the said Ordinance described in this Resolution be, and the same hereby is, submitted to the aualified electors of the said City of Grand Junction, Colorado, for their adoption or rejection; that at said regular election the question of the issuance and sale of bonds described in said Ordinance be, and the same is hereby submitted to the qualified tax-paying electors of the said City of Grand Junction, Colorado, under the law, for

their adoption or rejection; that the questions so submitted shall be voted on at the said election at the following designated polling places, to-wit:

Precinct No. 9: Polling place at City Hall Precinct No. 10: Polling place at 226 Main St Precinct No. 11: Polling place at the Y.M.C.A. Building Precinct No. 12: Polling place at 122 North Seventh St Precinct No. 16: Polling place at 222 North Seventh St

The votes shall be by ballot of the form hereinafter provided and said election shall be in all respects, as near as may be, in the manner prescribed by the laws of the State of Colorado and the Charter and Ordinances of the City of Grand Junction, Colorado, in cases of election for municipal officers.

The ballots to be used in voting shall be provided and furnished by the City Clerk to the judges of election and by them to be furnished to the voters, and on the question of the adoption or rejection of the said Ordinance shall be substantially in the following printed form:

The following resolution was introduced and read:

RESOLUTION

WHEREAS, the City of Grand Junction is the owner of the North half of Block 84, in said City, and the County of Mesa is the owner of the South half of said Block, and

WHEREAS, School District No. 1 of Mesa County is the owner of Block 95, in said City, which block is now being used for School purposes, and

WHEREAS, it is desired by many people that an exchange be effected by which the City would become the owner of the West half of said Block 95, the County the owner of the East half of said Block 95 and the said School District the owner of Block 84, subject to certain reservations and exceptions.

THEREFORE, be it resolved that an Ordinance entitled, "An Ordinance Concerning the Exchange by the City of Grand Junction

and County of Mesa of Block 84 of said City for Block 95 of said City, now owned by said School District No. 1" be submitted to the vote of the qualified electors of said City for their adoption or rejection at the regular election to be held November 6th, 1917.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the resolution as introduced and read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried and the resolution passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the Commissioner of Finance and Supplies be authorized and instructed to contract for the purchase of one earload of coal for the several city departments, as per bid submitted by the Juanita Sales Co. of September 28th, quoting a price of \$5.25 per ton.

The motion being put, upon call of roll, the Commissioners voted as follows: Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the Council then adjourned.
