Grand Junction, Colorado November 7, 1917

The City Council of the City of Grand Junction convened in regular adjourned session at four o'clock, p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Rankin, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of October 30 were read and approved.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the same was referred to the Mayor.

A communication from Robert Follansbee, District Engineer, in ference to the completion of the water guaging station at the Kannah Creek intake, was presented and read.

A communication from the County Assessor of Mesa County, stating that the assessed valuation of the City of Grand Junction for the year 1917-18 was \$6,816,792.00, was presented and read. On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the communication was accepted and ordered placed on file.

Moved by Commissioner Rankin, seconded by Commissioner Blackstone, that J. H. Cloviduce be granted a rate of \$3.00 per quarter for water taken from Ivan Rooks' hydrant on Orchard Mesa.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the Mayor appoint a committee of three to investigate the matter of leasing or buying a coal mine for the City to be operated as a municipal coal mine and furnish coal to the people of the city at cost, unless the price of the best grades of lump coal be dropped to \$5.50 per ton by the local dealers.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

The Mayor appointed Commissioners Vorbeck, Blackstone and Holmburg to serve on said committee.

The report of the City Weiger for the month of September having been examined and approved by the Mayor, the same was on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, accepted and ordered placed on file.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, H. A Van Gundy of the city of Grand Junction is the owner of certain real estate hereinafter described and desires to connect with Sewer District No. 3, and has paid to the City-Treasurer the sum of \$17.50 for such connection; therefore, be it

RESOLVED, that the said Van Gundy, his heirs and assigns, be permitted to connect with Sewer District No. 3 the following described real estate located in Mesa county, Colorado: The south 25 ft. of the following tract, beginning 591 1-4 ft. south of the intersection of the east side of Fifth street with the north boundary line of the s. c. quarter of n. w. quarter of Section 13, T. 1 S., R. 1 W., Ute Meridian, thence east 111 1-2 ft., thence south 100 ft., thence west 111 1-2 ft., to the east line of said Fifth street, thence north 100 ft. to place of beginning.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioner voted as follows: Cherrington, yea; Rankin, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea; the Mayor declared the motion carried and the resolution passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that Geo. W. Armstrong, as Justice of the Peace, be appointed a member of the canvassing board in place of Mayor Chas. E. Cherrington, candidate for re-election as Commissioner of Public Affairs.

The motion carried by a unanimous vote of the Council.

On motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the Council adjourned until to-morrow, November 8th, at 10 o'clock a.m.
