

Grand Junction, Colorado
November 28, 1917

The City Council of the City of Grand Junction convened in regular adjourned session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vedder, Vorbeck, Holmburg. Absent: Commissioner Blackstone.

The proof of publication of a proposed ordinance, entitled "The Annual Appropriation Ordinance of the City of Grand Junction, Colorado, providing for the Expenses and Liabilities of the City of Grand Junction for the Fiscal Year beginning January 1, 1918, and ending December 31, 1918," was presented and read.

On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the proof of publication was accepted and ordered placed on file.

The proposed ordinance was then taken up for final passage and read by the Clerk.

Moved by Commissioner Vedder, seconded by Commissioner Holmburg, that the proposed ordinance be amended by making the tenth paragraph of section 1 thereof read as follows: For care and improvement of the public parks, \$4,100.00.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Holmburg, yea.

All the Commissioners present having voted yea, the motion was declared carried and the amendment passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Vedder, that the proposed ordinance as amended and entitled "The Annual Appropriation Ordinance of the City of Grand Junction, Colorado, providing for the Expenses and Liabilities of the City of Grand Junction for the Fiscal Year beginning January 1, 1918, and ending December 31, 1918," be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Holmburg, yea.

All the Commissioners present having voted yea, the Mayor declared the motion carried and the ordinance passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the ordinance just passed be numbered 259.

The motion carried and it was so ordered.

The proof of publication of a proposed ordinance, entitled "An Ordinance Levying a Special Assessment on Certain Real Estate of Grand Junction for Benefits Conferred by the Water System of said City," Was presented and read.

On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the proof of publication was accepted and ordered placed on file.

The proposed ordinance was then taken up for final passage and read by the Clerk.

Moved by Commissioner Vorbeck, seconded by Commissioner Vedder that the proposed ordinance as read and entitled "An Ordinance Levying a Special Assessment on Certain Real Estate of Grand Junction for Benefits Conferred by the Water System of said City," be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Holmburg, yea.

All the Commissioners present having voted yea, the Mayor declared the motion carried and the proposed ordinance passed and adopted.

Moved by Commissioner Holmburg, seconded by Commissioner Vorbeck, that the ordinance just passed be numbered 260.

The motion carried and it was so ordered.

On motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the Council adjourned.
