

Grand Junction, Colorado
December 4, 1917

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vedder, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of November 27th and adjourned session of November 28th were read and approved.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Holmburg, the same was referred to the Mayor.

The official bond of Dr. Carl W. Plumb, City Health Officer, having been examined and approved by the City Attorney, the same was, on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, accepted and ordered placed on file.

Moved by Commissioner Blackstone, seconded by Commissioner Vedder, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the bills allowed.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, under the terms and provisions of Ordinance No. 178 as amended, the City Council has created Sidewalk District No. 2,

of the City of Grand Junction, Colorado, and the said Council has caused to be published as required by said Ordinance, a Notice of the completion of said District and apportionment of the costs thereof; and

WHEREAS, no written objections or any other objections have been filed with the Clerk with respect to the proposed assessment of costs of said improvement.

THEREFORE, BE IT RESOLVED that the time under said Ordinance as amended, for filing objections of any kind against the acceptance of said work and the assessment therefor, has now expired and the said improvement is hereby confirmed; all being in pursuance of said Ordinance.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

A proposed ordinance, entitled "An Ordinance Approving the whole cost of the Improvements made in and for Sidewalk District No.2 in the City of Grand Junction, Colorado, pursuant to Ordinance No. 178, adopted and approved June 11, 1910, as amended, and pursuant to the Resolutions and Proceedings of the City Council, adopted pursuant to said Ordinance No. 178, as amended, Approving the Apportionment of said Costs to each Lot or Tract of Land in said District, Assessing the share of said Costs against each Lot or Tract of Land in said District, and Prescribing the Manner for the Collection and Payment of said Assessment," was introduced and read.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the proposed ordinance passed for publication.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the Council then adjourned.
