

Grand Junction, Colorado
December 29, 1917

All the Commissioners having been duly notified, the City Council of the City of Grand Junction convened in special session at 9 o'clock a. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vedder, Vorbeck, Blackstone, Holmburg.

Moved by Commissioner Blackstone, seconded by Commissioner Vedder, that the bills as read be allowed and warrants ordered drawn for the several amounts.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the bills allowed.

The City Clerk submitted to the Council a certified list of names

of persons whose names appear on the registration lists of the several voting precincts of the city and not shown on the poll lists to have voted at the regular municipal election held November 6, 1917.

Moved by Commissioner Vedder, seconded by Commissioner Blackstone, that the list of non-voters as submitted by the Clerk be accepted and filed, and that the Clerk be instructed to notify all persons whose names appear on said list to appear on one of the following named days before a committee of the City Council namely: Monday, February 4; Thursday, February 7, and Tuesday, February 12, 1918, to show satisfactory cause why their names should be retained on the registration lists of the city.

The motion carried, and the Mayor thereupon appointed Commissioners Vorbeck and Holmburg to serve, with himself, as a committee to sit on the days named in said notice to hear reasons why the names of such persons not voting at said election should be retained on the registration lists of the several voting precincts of the city.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the Council adjourned until Monday, December 31, at 4 o'clock p. m.
