

Grand Junction, Colorado
January 15, 1918

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present:
Cherrington, Vedder, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of December 18 and special meetings of December 29 and 31, 1917, and regular meetings of January 2d and 8th were read and approved.

The following bonds having been examined and approved by the City Attorney, it was moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the same be accepted and ordered placed on file:

H. Goodman, Junk Dealer;

Coldberg & Leff, Junk Dealers;

John Fuite, Plumber, and

A. O. Shaff, Garbage Collector.

The motion carried by a unanimous vote of the Council.

John Fuite having made application for renewal of license as plumber, it was moved by Commissioner Vedder, seconded by Commissioner Blackstone, that the license be granted.

The motion carried.

The following resolution was introduced and read:

Resolution.

Whereas,

In selling the bonds for the purchase of the Fair Grounds the City Treasurer credited the proceeds from such sale on his records, both principal and premium to a so called Special Park Fund, and charged against such fund the \$20500.00 payment for said property and,

Whereas,

Bond #41 of the issue for the purchase of said Fair Grounds has not been sold and is still in the hands of the City Treasurer, and,

Whereas,

There is at this time a debit balance of \$III.70 in said Special Park Fund; be it therefore

Resolved,

That a warrant on the General Fund be drawn payable to said Special Park Fund to balance said debit in said account of \$III.70, and be it further

Resolved,

That the City Treasurer be authorized, and he is hereby instructed to cancel said bond #4I which has not been issued.

Moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea;

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

The quarterly reports of the City Treasurer and the Commissioner of Highways were submitted and read, and on motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the same were referred to the Auditor.

The following reports were submitted and read, and on motion of Commissioner Holmburg, seconded by Commissioner Vedder, the same were accepted and ordered placed on file:

Annual Report of the City Health Officer;

Annual Report of the Chief of the Fire Department;

Quarterly Report of the Judge of the Municipal Court.

The monthly report of the City Weigher having been examined and approved by the Mayor, the same was, on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, accepted and ordered placed on file.

1 Corey hydrant,

1 Ludlow hydrant,

500 ft. 1-2 in. Galvanised pipe,

200 ft. 3-4 in. Galvanised pipe,

1,000 ft. 2 in. Galvanised pipe.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

Moved by Commissioner Holmburg, seconded by Commissioner Vedder, that the Commissioner of Finance and Supplies be instructed to get bids for one carload of lump coal for city departments.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

On motion of Commissioner Blackstone, seconded by Commissioner Holmburg, the Council adjourned.
