

Grand Junction, Colorado
February 19, 1918

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

The following Commissioners, upon call of roll, responded as present:
Cherrington, Vedder, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of February 12 and adjourned session of February 13 were read and approved.

A communication from the Chamber of Commerce, asking the Council to have an arc light placed at the intersection of Eleventh and Main streets, was presented and read. On motion of Commissioner Holmburg, seconded by Commissioner Vorbeck, the Communication was referred to the Mayor.

Moved by Commissioner Vedder, seconded by Commissioner Blackstone, that the Commissioner of Finance and Supplies be authorized and instructed to purchase a Ford auto car for the Water Department.

The motion being put, upon call of roll, the Commissioners voted as follows:
Cherrington, no; Vedder, yea; Vorbeck, no; Blackstone, yea; Holmburg, no.

A majority of the Commissioners having voted no, the Mayor declared the motion lost.

B. F. Gant having applied for a junk dealer's license, it was moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the license be granted, subject to the filing and approval of the proper bond.

The motion carried.
