## Grand Junction, Colorado March 5, 1918

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present: Cherrington, Vedder, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of February 26th and the special session of March 1st were read and approved.

The monthly report of the City Weigher was submitted and read, and on motion of Commissioner Vedder, seconded by Commissioner Blackstone, the same was referred to the Mayor.

The bond of Ben F. Gant, junk dealer, having been examined and approved by the City Attorney, the same was on motion of Commissioner Holmburg, seconded by Commissioner Blackstone, accepted and ordered placed on file.

The depository bond of the United States Bank & Trust Co. having been examined and approved by the City Attorney, it was moved by Commissioner Vorbeck, seconded by Commissioner Holmburg, that the same be accepted and placed on file.

The motion carried.

In reference to the claim of R. Pemberthy for damages sustained on account of backing up of sewer, Commissioner Vedder recommended that Mr. Pemberthy be paid \$7.50 for damages.

Moved by Commissioner Vorbeck, seconded by Commissioner Vedder, that the recommendations of the Commissioner of Water and Sewers be concurred in by the Council, and that \$7.50 be paid to Mr. Pemberthy for damages sustained.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

WHEREAS, the said McKinnon has recently died leaving no estate, therefore, be it

RESOLVED, that the Commissioner of Finance and Supplies is hereby authorized and instructed to cancel the said note.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea. All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

On motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the Council adjourned.
