

Grand Junction, Colorado
March 19, 1918

The City Council of the City of Grand Junction convened in regular session at four o'clock p. m., in the City Hall, with Mayor Cherrington in the chair.

Upon call of roll, the following Commissioners responded as present:
Cherrington, Vedder, Vorbeck, Blackstone, Holmburg.

City Attorney Tupper was present.

The minutes of the regular meeting of March 12 and adjourned session of March 14 were read and approved.

A communication from S. R. Schaeffer, certified public accountant, making application to serve the city for another year on the same terms as last year, was read.

Moved by Commissioner Holmburg, seconded by Commissioner Vedder, that the application of Mr. Schaeffer be accepted, and that he be employed to audit the City's books and accounts for the current year, at the same rate as paid for last year's audit.

The motion being put, upon call of roll, the Commissioners voted as follows:
Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

The monthly report of the City Weigher having been examined and approved by the Mayor, the same was, on motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, accepted and placed on file.

Moved by Commissioner Holmburg, seconded by Commissioner Blackstone, that the proposed ordinance as read be passed for publication.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the proposed ordinance passed for publication.

The following resolution was introduced and read:

RESOLUTION.

WHEREAS, in Paving and Sidewalk District No. 5 an assessment was made on the south 50 feet of Lot 27, in Block 123, in the City of Grand Junction, Mesa County, Colorado, which assessment was in error as to the east 10 feet thereof, and

WHEREAS, the said south 50 feet of Lot 27 has been sold twice because of non payment of the said assessment and Certificates No. 18,795 and No. 20,104 have been issued to the City of Grand Junction; on the last mentioned certificate the assessment payable in 1918 has been endorsed; therefore, be it

RESOLVED, that the assessment plat book of said district be corrected so as to show no assessment against the east ten feet of said south 50 feet of Lot 27; that the County Treasurer of Mesa County, Colorado, be and he is hereby authorized and requested to release from said sale certificates the east ten feet of the south 50 feet of Lot 27, in Block 123, in the City of Grand Junction, Mesa County, Colorado.

Moved by Commissioner Vorbeck, seconded by Commissioner Vedder, that the resolution as read be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried and the resolution passed and adopted.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the Council adjourned.
