Quarterly Report of the City Treasurer.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the reports were referred to the Auditor.

The quarterly report of the City Clerk and Auditor was submitted and read, and on motion of Commissioner Vedder, seconded by Commissioner Blackstone, the same was referred to the Commissioner of Finance and Supplies.

The proof of publication of a proposed ordinance, entitled "An Ordinance Concerning Theatres," was presented and read.

On motion of Commissioner Vorbeck, seconded by Commissioner Blackstone, the proof of publication was accepted and ordered placed on file.

Moved by Commissioner Holmburg, seconded by Commissioner Vedder, that the proposed ordinance be taken up for final passage.

The motion carried, and the proposed ordinance was then read by the Clerk.

Moved by Commissioner Holmburg, seconded by Commissioner Vedder, that the proposed ordinance as read and entitled "An Ordinance Concerning Theatres," be passed and adopted.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Vorbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the Mayor declared the motion carried and the ordinance passed and adopted.

Moved by Commissioner Vorbeck, seconded by Commissioner Blackstone, that the city clerk be authorized and instructed to offer one cent per pound for dandelion roots brought to the City Hall on or before June 1st, 1918, and that a prize of a \$5.00 war stamp be given the boy or girl under 15 years of age bringing the largest number of pounds of such roots, and a prize of ten thrift stamps for the second largest number of pounds on or before said date, such roots to be dug within the city limits and free from dirt.

The motion being put, upon call of roll, the Commissioners voted as follows: Cherrington, yea; Vedder, yea; Verbeck, yea; Blackstone, yea; Holmburg, yea.

All the Commissioners having voted yea, the motion was declared carried.

On motion of Commissioner Holmburg, seconded by Commissioner Blackstone, the Council adjourned.
